### **Non-Service-Connected Pension**



A monetary support benefit awarded to permanently and totally disabled, low-income veterans with 90 days or more of active military service of which occurred during a War Era.



### **VA Pension Continued**



- Pension is a tax-free financial benefit paid to qualifying Veterans.
- The purpose of Pension is to provide supplemental income to achieve minimum pension threshold.
- Amount awarded depends on current income and presence of dependents (spouse, children).

### **Basic Pension Summary**



- Must have served at least 90 days, with at least 1 day during wartime
  - World War II (December 7, 1941 to December 31, 1946)
  - Korean conflict (June 27, 1950 to January 31, 1955)
  - Vietnam War era (February 28, 1961 to May 7, 1975, for Veterans who served in the Republic of Vietnam during that period. August 5, 1964 to May 7, 1975, for Veterans who served outside the Republic of Vietnam.)
  - Gulf War (August 2, 1990 through future date to be set by law/presidential proclamation)
- Must be at least age 65 OR have a permanently and totally disabling nonservice-connected medical condition
- Must have income and estates under set financial threshold limits

# Special Monthly Pension Summary



<u>Special Monthly Pension (SMP)</u>- Higher payment amount for Veteran's with non-service connected conditions

- Aid & Attendance Veteran requires help with ADLs OR has visual acuity of 5/200 (20/800) or less or concentric contraction of visual field to 5 degrees or less in the better eye with best correction
- Housebound Veteran who is confined to home OR has visual acuity of 20/200 or less or concentric contraction of visual field to 20 degrees or less in the better eye with best correction
- Information: <u>Enhanced or Special Pension</u>
- Application: <u>VA Form 21-2680</u>, (Veteran must also include <u>VA Form 21P-527EZ</u> if they do not already receive basic Pension)



### **COMPENSATION**



A monetary benefit paid monthly to veterans who are disabled by an injury or illness that was incurred or aggravated during active military service

# Special Monthly Compensation Summary



<u>Special Monthly Compensation (SMC)</u>- Higher payment for loss, or loss of use of, specific body parts for Veterans with service-connected disabilities

- · Loss, or loss of use, of a hand or foot
- Immobility of a joint
- Paralysis
- Loss of sight of an eye (only seeing light)
- Loss, or loss of use, of a reproductive organ
- · Complete loss, or loss of use, of both buttocks
- Deafness of both ears (no air and bone conduction)
- Inability to communicate by speech (complete organic aphonia)
- Loss of a percentage of tissue from single breast/both breasts, from mastectomy or radiation treatment

<sup>\*</sup>VBA uses terms "Aid & Attendance" and "Housebound" for certain higher levels of SMC



### Compensation vs. Pension



### **Compensation**

- Based on injuries or illness incurred during service
- No wartime period requirement
- May qualify for Special Monthly Compensation (SMC, A&A/HB) based on extent of SC disability

### **Pension**

- Financial needs based (income & assets)
- Must be over 65 OR have a non-service connected disability
- Must have served during wartime period




### **Individual Unemployability**



A Service-Connected veteran with a single disability rated at 60% or more, or more than one disability where at least one of the disabilities is rated at 40% and the additional disabilities provide a combined rating of 70% or more may be deemed unemployable. VA Individual Unemployability Factsheet



### **Paired Organs**



Compensation is payable for combinations of service connected and Non-service-connected injury or loss of paired organs, provided the non-service Connected disability is not the result of a veteran's willful misconduct.



### **Auto Grant**



Financial assistance, in the form of a one-time grant, is available to purchase or modify a new or used automobile to accommodate a veteran with certain disabilities resulting from an injury or disease incurred or aggravated during active military service. The current grant amount is 2021 Rate: \$21,795.57 (one time).



### **Clothing Allowance**



Any veteran who is service-connected for a disability for which he or she uses prosthetic or orthopedic appliances may currently receive an annual clothing allowance in the amount of 2021 Rate: \$830.56.



## Chapter 35: Survivors' and Dependents' Education Assistance



Provides education and training opportunities to eligible dependents of certain veterans. This program offers up to 45 months of education support. Benefits may be used for degree and certificate programs, apprenticeship, and on-the-job training.



## Vocational Rehabilitation Eligibility



- Vocational Rehabilitation [10% SC or higher]
  - Period of Eligibility: 12 years from date received notice
    - Date of separation from active military service
    - First VA SC disability rating

### **HISA Grant**




VA currently provides up to 2021 \$6,800 (SC)
lifetime benefit for service-connected veterans and up to \$2,000 for
Non-service-connected veterans to make home
improvements that are medically necessary or
structural accommodations related to the service
connected disability.

### Allowable adaptations include:

- Entrance or exit from veteran's residence
- Essential lavatory and sanitary facilities
- Access to kitchen or bathroom sinks or counters
- Improving entrance paths or driveways
- Improving plumbing or electrical systems necessary for dialysis equipment in the home



- VA Life Insurance
  - Guarantees access to life insurance for SC Veterans
  - VA Life does not offer premium waivers
  - Information: <u>Veterans Affairs Life Insurance (VALife)</u>
  - Application: <u>VA Life Insurance | Veterans Affairs</u>
- Service-Disabled Veterans Life Insurance (S-DVI)
  - No longer accepting new applications (as of 12/31/22)
  - Cannot transfer waiver to VA Life



## **Special Housing Adaptations**



## 2101a (Special Housing Adaptations): 2021 Rate: \$100,896 (total maximum amount)


- Eligibility: Must meet both criteria below:
- Own or will own the home, and
- Have a qualifying service-connected (SC) disability, which includes:
  - The loss or loss of use of more than one limb
  - The loss or loss of use of a lower leg along with the residuals (lasting effects) of an organic (natural) disease or injury
  - Blindness in both eyes (with 20/200 visual acuity or less, including visual field loss of 20 degrees or less)
  - Certain severe burns
  - The loss, or loss of use, of one lower extremity (foot or leg) after September 11, 2001, which makes it so
     Veteran can't balance or walk without the help of braces, crutches, canes, or a wheelchair.

## 2101b (Specially Adapted Housing): 2021 Rate: \$20,215 (total maximum amount)

- Eligibility: Must meet both criteria below:
- Own or will own the home, and
- Have a qualifying service-connected (SC) disability, which includes:
  - The loss or loss of use of both hands
  - Certain severe burns
  - Certain respiratory or breathing injuries.



### **CHAMPVA**



- CHAMPVA: Dependents of 100% SC Veteran
  - The Civilian Health and Medical Program of the Department of Veterans Affairs (CHAMPVA) is a comprehensive health care program in which the VA shares the cost of covered health care services and supplies with eligible beneficiaries

#### Catastrophically Disabled (CD)

**Note**: Catastrophically Disabled is a designation made by the Veterans Health Administration (VHA) that is based on a clinical decision. Veterans are considered CD when they have a severely disabling injury, disorder or disease that permanently compromises their ability to carry out the activities of daily living. A finding of Legal Blindness by an Eye Doctor is a qualifying condition. Special benefits include:

- O Medical: Priority Group 4 (unless eligible for a higher priority group)
  - All VA medical care, excluding dental care unless otherwise eligible
  - Long-term care, including short-term (If space and resources are available) or indefinite nursing home care for veterans whose service-connected condition is clinically determined to require nursing home care)
- O Exemption from copayments for the following care:
  - Inpatient care at VA facilities or at VA expense
  - Outpatient care at VA facilities or at VA expense
  - Prescription medication provided by VA pharmacy or VA expense
  - Non-institutional respite care
  - Non-institutional geriatric evaluation
  - Non-institutional adult day health care
  - Homemaker/Home Health Aide
  - Purchased skilled home care
  - Home Based Primary Care (HBPC)
  - Any other non-institutional alternative care services
- O Copayments **STILL** apply for other extended care services (for example: Nursing Home Care)



### **Beneficiary Travel**



- Beneficiary Travel Reimbursement for mileage and other travel expenses to and from approved health care appointments. \$0.415/mile
  - Must meet at least one of the following:
    - 30% SC or higher
    - Traveling for treatment of SC condition, even if rated less that 30%
    - Receive VA Pension / have income below pension threshold
    - Traveling for scheduled VA compensation exam
    - Traveling to get a service dog
- BT for Blind Rehab- reimbursement for mileage/travel expenses to and from Blind Rehab
  - Must meet one of the following:
    - Need in-patient Blind Rehab care
    - Getting temporary lodging approved by VA



### **Special Mode Transportation**



- Special Mode Transportation- ambulance, wheelchair van. Must meet all of the following:
  - Administratively eligible for travel (30% SC or below income)
  - VA health care provider determines medical necessity for SMT
  - Traveling for VA approved appointments
- Special Mode Transportation Veterans w Visual Impairments
  - Regardless of Veteran's ability to move from one place to another, it is unsafe to access other forms of transportation
  - VA health care provider enters one of the vision impairment ICD-10 codes with note stating, "Veteran cannot safely ambulate due to no safe access to other types of transportation" (this satisfies medical justification)



## **Caregiver Support Program**




<u>Caregiver Support Program</u>- Provides resources, education and support to caregivers of Veterans

- CSP Two Programs
  - Program of General Caregiver Support Services (PGCSS)
    - Service Connection not required
  - Program of Comprehensive Assistance for Family Caregivers (PCAFC)
    - Must be 70% SC
- Contact your <u>local Caregiver Support Coordinator</u> for local referral/application process


• <u>Note</u>: An 1151 claim for VA benefits allows veterans to receive compensation when a qualifying additional condition/disability or an existing injury or disease became worse resulting from the carelessness or negligence on the part of VA during medical care, or been caused by participation in a compensated work therapy program, such as vocational rehabilitation. Special benefits include:

•

- Medical: Priority Group 3 (unless eligible for a higher priority group)
  - All VA medical care, excluding dental care unless otherwise eligible
  - Long-term care, including short-term (If space and resources are available) or indefinite nursing home care for veterans whose serviceconnected condition is clinically determined to require nursing home care)
- O VA compensation and special benefits for the specific disability or appropriate for the percentage of service-connected disability awarded.

- Medical: Priority Group can be assigned 1 through 8 and is determined by other eligibility factors (no special consideration)
- All VA medical care, excluding dental care (unless otherwise eligible)
  - Long-term care, including short-term (If space and resources are available) or indefinite nursing home care for veterans whose service-connected condition is clinically determined to require nursing home care)
- O Department of Defense (DoD)
  - Combat Related Special Compensation (for certain qualifying military retirees only)
    - Survivors Benefit Plan (SBP) (for certain military retirees only)
    - Commissary and Exchange privileges
    - Lifetime Space-A (Space Available) travel benefits
    - Tricare healthcare benefits

### **Women Veterans**

- Medical: Priority Group is determined by other eligibility factors (no special considerations)
  - All VA medical care, excluding dental care (unless otherwise eligible)
- Long-term care, including short-term (If space and resources are available) or indefinite nursing home care for veterans whose service-connected condition is clinically determined to require nursing home care)
  - Women's health specialty health care (e.g., advanced breast and gynecological care, maternity care, and some infertility treatments)
  - Women Veterans Program Managers are available to assist women Veterans at each VA Medical Center
- O Other

  - All VA medical care, and possibly some limited dental care (unless otherwise eligible)
  - Long-term care, including short-term (If space and resources are available) or indefinite nursing home care for veterans whose service-connected condition is clinically determined to require nursing home care)
  - Domiciliary Care for Homeless Veterans (DCHV) Program
  - Health Care for Homeless Veterans (HCHV) Program
  - Women Veterans Program Managers are available to assist women Veterans at each VA Medical Center
- O Other

### **Active-Duty Service Members**



#### **Active Duty Service Members**

<u>Note</u>: Active-Duty Service Members can receive treatment in VA facilities and certain VA programs, including Blind Rehabilitation Service. The goal is early intervention and a smooth handoff between DoD and VA. Care managers in DoD are responsible to reaching out to VA facilities and program offices to initiate care request from VA. If VIST is contacted directly by the Service Member or their family they should be instructed to work with their DoD care manager to facilitate referral and appropriate handoff.

- O Medical: Per special agreement/arrangement between VA and DoD. The level and type of care available can vary from one VA to another.
  - VA medical care, and possibly some limited dental care based on interagency agreement. This **does** include Blind Rehabilitation and Low Vision Services at VA facilities.
  - Prosthetic equipment prescribed by VA providers and therapists.
- O VA Compensation if compensable disability exists once separated or retired from DoD
- Automobile Allowance/Grant (if eligibility criteria is met)
- O Department of Defense (DoD)



Eight priority groups have been established to help ensure that VA resources are allocated to veterans with the highest priority for VA care. Priority Group 1 is the highest priority and Priority Group 8 is the lowest. Priority level funding may change from year to year, depending on congressional funding. If VA cannot renew your enrollment for the following year, you will be notified 60 days before your current enrollment period expires. Enrollment for VA health-care will occur based on the following priorities:

#### **Priority Group 1**

Veterans with service-connected (SC) conditions who are rated 50% or more disabling Veterans determined by VA to be unemployable due to service-connected conditions Veterans that have received the Medal of Honor (MOH)

#### **Priority Group 2**

Veterans with VA rated service-connected (SC) conditions who are rated 30% or 40% disabling

#### **Priority Group 3**

Veterans who are Former Prisoners of War (POWs)

Veterans who have received the Purple Heart medal

Veterans with service-connected (SC) disabilities rated 10% or 20% disabling

Veterans discharged from active duty for a disability that was incurred or aggravated in the line of duty

Veterans awarded special eligibility classification under Title 38, U.S.C., Section 1151, "benefits for individuals disabled by treatment or vocational rehabilitation"

#### **Priority Group 4**

Veterans who are receiving aid and attendance or housebound benefits from VA Veterans who have been determined by VA to be catastrophically disabled



### **Priority Groups Continued**



#### Priority Group 5

- Nonservice-connected (NSC) Veterans and non-compensable service-connected (SC) veterans rated 0% disabled by VA with annual income below the VA's and geographically (based on resident zip code) adjusted income limits
- Veterans receiving VA pension benefits (basic rate only)
- Veterans eligible for Medicaid programs

#### Priority Group 6

- Compensable 0% percent service-connected (SC) veterans
- Veterans exposed to Ionizing Radiation during atmospheric testing or during the occupation of Hiroshima and Nagasaki
- Project 112/SHAD participants
- Veterans who served in the Republic of Vietnam between January 9, 1962 and May 7,
   1975
- Veterans of the Persian Gulf War who served between August 2, 1990 and November 11, 1998
- Veterans who served on active duty at Camp Lejeune for at least 30 days between August 1, 1953 and December 31, 1987
- Currently enrolled Veterans and new enrollees who serve in a theater of combat operations after November 11, 1998 and those who were discharged from active duty on or after January 28, 2003, are eligible for the enhanced benefits, for 5 years post discharge.



### **Priority Status Continued**



#### **Priority Group 7**

Veterans with gross household income above the VA and the geographically-adjusted income limits for their resident location and who agree to pay copays

#### Veteran's ELIGIBLE for enrollment

Noncompensable 0% service-connected:

Subpriority a: Enrolled as of January 16, 2003 and who have remained enrolled since that date and/or placed in this sub priority due to

changed eligibility status

Subpriority b: Enrolled on or after June 15, 2009 whose income exceeds the current VA or geographic income limits by 10% or less

#### Nonservice-Connected and:

**Subpriority c:** Enrolled as of January 16, 2003 and who have remained enrolled since that date and/or placed in this sub priority due to changed eligibility status

Subpriority d: Enrolled on or after June 15, 2009, whose income exceeds the current VA or geographic income limits by 10% or less

#### Veteran's NOT eligible for enrollment

Veterans not meeting the criteria above:

**Subpriority e:** Non-compensable 0% service-connected (eligible for care of their SC condition only)

Subpriority g: Nonservice-connected

**NOTE-1:** Veterans assigned to Priority Groups 8e or 8g are not eligible for enrollment as a result of the enrollment restriction which suspended enrolling new high-income veterans who apply for care after January 16, 2003.

**NOTE-2:** VHA Directive 2000-001, dated January 4, 2000 found that ALL legally blinded veterans will automatically be placed in priority category 4 or higher, if their VA rating qualifies for a higher Priority Group assignment.

# State Veterans Benefits (Local Benefits and Services)



Each State manages its own benefits programs. These benefits may include educational grants and scholarships, special exemptions or discounts on fees and taxes, home loans, veteran's homes, free hunting and fishing privileges, and more.



## Services Exclusively Available or Prioritized to Veterans



- Commissary and Exchange Privileges
- Savings on travel privileges with a military card
- Talking Book (preference goes to veteran's)
- License plates (depending on eligibility and state).
   For example, Retired Military plate, Purple Heart Plate, Disabled Vet Plate, etc.
- Property Tax Exemptions (depending on eligibility and state law or local ordinance)



### **Services for Veterans (cont)**



- College benefits (varies by state depending on eligibility and state law or college policy)
- Reduced entry fees for some parks, etc. (will vary greatly)
- Free Fishing/Hunting License (may extend to non-veteran disabled population)
- Free Drivers License (varies by state, etc.)
- Seeing Eye waives their admission fee for blinded veterans
- Free meal at Golden Corral Restaurants on Veteran's Day and/or Memorial Day



### Veterans Consumer Organizations



- Blinded Veterans Association (BVA) -established specifically to help veterans and their families
- Blinded American Veterans Foundation (BAVF) designed to become a focal point and clearinghouse for research, information dissemination and education efforts



### Non-VA Consumer Organizations



- American Council of the Blind (ACB) advocacy organization active in promoting the rights of people in the U.S.
- The National Federation of the Blind (NFB) oldest and most active advocacy organization for the blind in the U.S



#### Other Services/Resources



- American Foundation for the Blind (AFB) –national nonprofit organization devoted to ensure blind and visually impaired enjoy same rights and opportunities as other citizens.
- State Commissions for the Blind —offer services to help individuals regain independence and find employment.
- The Hadley School for the Blind is the largest worldwide distance educator of blind and visually impaired people, their families and blindness service professionals.
- Library Services for the Blind and Physically Handicapped
   NLS administers a free library program of Braille and audio materials by postage free mail (aka Talking Books)



### Other Services/Resources (cont)



- Learning Alley formally Recording for the Blind & Dyslexic (RFB&D) offers an online catalog of the best audio books and audio learning opportunities on the internet. They maintain a library of textbook recordings and will make audio recordings of textbooks for students, if instructors use texts that are not currently available. There is a registration fee for this service.
- Dog Guide Schools anyone interested in training with a guide dog to research each of the programs listed in Guide Dog Schools in the U.S. link.
- Radio Reading Services services provide audio access to information to people who cannot read print and the services can be accessed via radio, web or telephone.



#### **Federal and State Resources**



- National Parks Pass Program A free, lifetime pass - available to U.S. citizens or permanent residents of the United States that have been medically determined to have a permanent disability.
- Postage Free Matter for the Blind Pub. 347 -Mailing Free Matter for the Blind and Visually Handicapped Persons.
- Handicapped Parking Permits Most states require a doctor's prescription along with an application form downloadable from the web.



#### Federal and State Resources (cont)



- Social Security Administration (SSA) You may qualify for Social Security or SSI disability benefits if you are considered "legally blind."
- Voting Accessibility Accessibility to voting area and voting privately - Help America Vote Act of 2002 (HAVA).
- Income Tax Deductions If you are blind on the last day of the year and do not itemize deductions, you are entitled to a higher standard deduction.


